- 3. Absenteeism discussion by Head Dean, some parents have informed school of extended trips beyond the 10 day limit. State is paying for scholar to attend school, if parent chooses to take trip beyond the 10 day limit, truancy court will be next step taken.
- 4. Head Dean informed on recent incident of an over the counter medication incident by a Middle Schooler, resulting procedures/actions taken (i.e., suspension of scholar, other scholars affected, locker check, plan of return).
- 5. EA School Business Administrator provided update in regards to BCCS' SY2016-2017 Audit has been finalized. Hard copies (i.e., 15-20 copies) will be provided by the Auditors shortly.
